


STÉPHANE DESCHÊNES

SUCCESS FOR NATURIST RAMBLER!

An item of major discussion at the recent Congress was about the legal problems in various countries where naturism is threatened. This recent report comes from the United Kingdom concerning a naturist Rambler who was charged with a public order offence last year. It confirms that not every case is lost by naturists.

A Rambler who strolled naked across a Leeds beauty spot has won a year-long battle against his conviction for a public order offence.

Naturist Nigel Keer, 42, has been appealing against the charges since magistrates found him guilty of causing distress to a woman who was walking her dog on Otley Chevin last October.

And yesterday a judge at Leeds Crown Court told him that the charges would be dismissed because it was unlikely that Mr Keer's naked walk had caused anyone any distress.

The court had heard that Mr Keer was arrested by off-duty police officer PC Mark Buxton, who said he saw a woman appear "distressed" when she had noticed Mr Keer rambling on the Chevin on October 11 last year. But Mr Keer had denied the claims, and said naturism "is about body freedom and in a way it is a mild protest against the expected social norms of wearing clothes every day."

Sitting with two justices, judge Guy Kearl said PC Buxton, who said he had been shocked by the incident, would not have been able to determine if the woman was distressed.

He said that the police officer's reaction to seeing Mr Keer could also be considered "extreme given his experience."

Dismissing the charges, he added: "This behaviour was not carried out in front of a school or in the street in a town centre. It took place on moorland in broad daylight.

"In view of the location of this incident, the time of day and the reaction of others as we have found it to be, we do not consider that anyone was likely to be harassed by this behaviour or intimidated or distressed."

The judge said there were no sexual motives behind incident, adding: "He was not deliberately flaunting himself or seeking attention or jumping out and doing what is colloquially called flashing."

As reported in the YEP, Mr Keer has taken part in three naked world bike rides alongside other naturists. Speaking after the case, Mr Keer said that he was delighted to have finally fought off the charges. He said the allegations had led to him being out of work for a number of months.

Mr Keer added: "I've kept up the naturism, but I've been a bit more careful now. "It's a bit cold to be doing anything at the moment, but once the weather warms up, I'll be back out there."

HOW DOES THE INF WORK?



Next year, the INF will be 60 years old. But the people who work and volunteer in federations around the world are generally much newer to the world of organized naturism. Since most of them likely haven't reviewed the INF Statutes in great detail, we thought it might be helpful to provide an overview of the INF organizational structure.

General Assembly (GA)

It is comprised of the member country's Federations and meets once every two years at the INF Congress. Each Federation is allowed one delegate. The delegate's number of votes is based on the number of members reported to the INF (and paid for) during the last two years preceding the Congress.

The location of each congress is determined at the previous congress and confirmed by the Executive Council. By tradition, every 5th congress (every 10 years) is held outside of Europe.

While suggestions and questions can be submitted at any time to the INF Executive Council, Central Council or General Secretariat, matters that have a significant impact on the running of the INF (e.g. motions, budget, or amendments to statutes) can only happen at the Congress where it is approved by the General Assembly.

Central Committee (CC)

The Central Committee takes care of the business of the INF. (more commonly known in other organizations as the board of directors) The CC is composed of the President, two Vice-Presidents, and two committee members who are elected for a 4-year period. One of the vice-presidents is responsible for finance (and therefore often referred to as Treasurer) while the other is responsible for the General Secretariat (Administration).

While the Central Committee is officially running the INF, the realities of distance means that it normally only meets twice per year. As such, most of the business is handled by the Executive Committee and approved by the CC.

Executive Committee (EC)

The Executive Committee consists of the President and the Two Vice-President. They meet regularly and provide the management for the INF. They are the ones who set the agendas and make proposals for projects and then execute those same projects when approved by the CC. The EC is also responsible for the General Secretariat.

General Secretariat (GS)

The General Secretariat handles the daily operations of the INF. It is the office of the INF and includes the only non-volunteers positions. Staff that is hired by the CC works full-time to ensure communications within the INF and to execute the projects created by the EC and approved by the CC.

Legal Commission (LC)

The Legal Commission is an appeals body that rules on complaints made by INF members regarding exclusion from the INF, transfer into another member group, number of contribution voting rights at the GA, violation of statutory rights, or violation by the CC of the statutes/rules made by the GA.

The LC is composed of the President, the Vice-President, one ordinary member, as well as two substitute members.

The LC can also be brought in to decide on disputes between member Federations.

Auditors

The Auditors review the INF finances to ensure that the finances were well managed and that funds were spent appropriately.
